Form ADV Part 3: Relationship Summary - Intentional Retirement, LLC

Introduction

Intentional Retirement, LLC ("Intentional Retirement" or "we") is an investment adviser registered with the U.S. Securities and Exchange Commission. We offer our clients investment advisory services. Clients should understand that the services we provide and fees we charge are different than those of a broker-dealer, and that it is important to understand the difference between the two. What Investment Services and Advice Can You Provide Me?

Description of Services: Intentional Retirement offers investment advisory services to retail investors. Our investment advisory services include: Asset Management Services and Financial Planning and Consulting Services.

<u>Asset Management Services</u>: We provide asset management services which involves us managing and trading your designated account(s). We will discuss your investment goals and design a strategy to try and achieve your investment goals. As a standard part of our services, we will continuously monitor your account when providing asset management services and contact you at least annually to discuss your portfolio. Asset management services are provided on a **non-discretionary** basis, meaning we will be required to contact you prior to implementing any trades in your account. For more information about investment authority, please see *Item 16* of our *Form ADV Part 2A*.

<u>Financial Planning & Consulting Services</u>: We also provide financial planning and consulting services. Financial planning services involve us creating a written financial plan for you which covers mutually agreed upon topics. Financial consulting is used when a written financial plan isn't needed. It involves one time and/or ongoing meetings to discuss your financial situation. Please see **Item 4** of our **Form ADV Part 2A**.

<u>Retirement Plan Participant Advice:</u> If your retirement plan utilizes our Retirement Plan Participant Advice Service, we are available at your request to provide one-on-one advice to you as a retirement plan participant regarding your investment options under the plan. Please see *Item 4* of our *Form ADV Part 2A*.

Limited Investment Offerings: We do not primarily recommend one type of security to clients. Instead, we recommend investment portfolios designed to be suitable for each client relative to that client's specific circumstances and needs. However, we are limited in investment selection in that we can only invest your account in securities which are available on your custodian/broker-dealer's platform. When providing you services, we do not recommend or offer advice on any proprietary products.

Account & Fee Minimums: We require a minimum of \$25,000 in order to open an account managed by us. To reach this account minimum, you can aggregate all household accounts. The minimum fee generally charged for financial planning services provided on an hourly basis is \$200 per hour with a 2.5 hour minimum (i.e. \$500). The minimum fixed fee generally charged for financial planning services on a fixed fee basis is \$2,500.The minimum hourly fee generally charged for consulting services is \$200 per hour with a 2.5 hour minimum (i.e. \$500).

What Fees Will I Pay?

Description of Principal Fees & Costs: Fees charged for our asset management services are charged based on a percentage of assets under management, billed in advance on a quarterly calendar basis, and calculated based on the fair market value of your account as of the last business day of the previous billing period. The annual fee for asset management services will be based upon a fee schedule which generally ranges between 0.70% and 1.00%. Because our fee is based upon the value of your account, we have an incentive to recommend that you increase the level of assets in your account. When engaging us for asset management services, you will also incur other fees and expenses. The broker-dealer/custodian on your account will charge you transaction fees for executing certain trades in your account. You will also be charged internal fees and expenses by the funds we invest in within your account.

Financial planning services are provided under an hourly fee arrangement. An hourly fee of \$200 per hour is charged by us for financial planning services under this arrangement. We also provide financial planning services under a fixed fee arrangement. The minimum fixed fee is generally \$2,500 and the maximum fixed fee is generally no more than \$5,000.

We provide financial consulting services under an hourly fee arrangement. An hourly fee of \$200 per hour is charged by us for financial planning services under this arrangement.

You will pay in advance a mutually agreed upon retainer that will be available for us to bill hourly fees against for our financial planning and consulting services. We will bill our financial planning and consulting fees to you on a monthly basis. Any fees we charge for financial planning and consulting services will not cover the costs associated with implementing any recommendations we may make.

Additional Information: You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying. What Are Your Legal Obligations to Me When Acting as My Investment Adviser? How Else Does Your Firm Make Money and What Conflicts of Interest Do You Have?

Standard of Conduct: When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

To the extent we recommend you roll over your account from a current retirement plan to an individual retirement account ("IRA") managed by us and subject to our asset-based investment advisory fees, this is a conflict of interest because we have a financial incentive to recommend that you move your IRA to us even if it is not in your best interest. For more information about this conflict and our procedures to mitigate the conflict, see Item 4 of our Form ADV Part 2A. When we provide asset management services, we will ask that you establish an account with Charles Schwab and Co. to maintain custody of your assets and to effect trades for your account. Our recommendation to use Charles Schwab and Co. is not based solely on your interest of receiving the best execution possible. We also recommend Charles Schwab and Co. because they provide us with research, products and tools that help us manage and further develop our business operations. As a result, we do not have to pay for such benefits, which saves us money; however, these arrangements create a conflict of interest. See Item 12 of our Form ADV Part 2A for more information about our arrangements with Charles Schwab and Co. We actively manage our own personal accounts while at the same time managing your accounts and other client accounts. This creates different conflicts of interest for which we have developed procedures to mitigate and control for those conflicts. For more information see Item 11 of Form ADV Part 2A. Our investment adviser representative also serves as an insurance agent. Through his role as such he may sell, for commissions, various insurance products. We have a conflict of interest in recommending these products to you because of the potential for additional revenue.

How Do Your Financial Professionals Make Money?

Description of Salary/Payment of IARs: We compensate our investment adviser representative with a salary, however, this individual is also an owner of our firm and thus will receive profit distributions or dividends. This creates a conflict of interest as it gives our representative an incentive to recommend you invest more in your account with us due to the additional fee revenue.

Our representative also serves as a licensed insurance agent. When acting in this capacity, the representative will receive commissions for selling insurance products. This creates a conflict of interest when the representative recommends you purchase insurance products through him.
